Membership Qualifications

Membership is available to any individual or corporation that is engaged in supplying or servicing the sewn products industry.

Classes of Membership

Supplier Member – Any individual, firm, or corporation that is engaged in or connected with supplying the sewn products industry.

Associate Member – Any individual, firm, or corporation that is a media representative, trade show organizer, or another trade association.

Membership Dues

Membership dues are based on gross revenues in U.S. Dollars and are payable on the honor system.

Annual membership is SPESA's fiscal year (May 1 – April 30).

Membership dues for applications submitted January 1 – March 31 qualify for a 50% discount off the above rates for the current fiscal year. After March 31 dues are applied to the next full fiscal membership year, and 100% of the dues amount is payable with the application.

Payment of Annual Dues – Membership is on an annual basis.

Annual membership dues are fully accrued on the first day of the fiscal membership year (May 1). However, Annual Dues may be paid on a quarterly basis with a 10% additional fee.
